DO I HAVE TO USE ONE OF THE SOLICITORS ON THE LIST?

IF I USE A SOLICITOR ON THIS LIST, DO I HAVE TO PAY A FEE?

- The solicitors on this list **DO NOT** work for free and you will need to pay for their services. It is your responsibility to ask the solicitor about their fees (including fees for the first interview) **BEFORE** you make an appointment.
- Some firms listed here conduct work on behalf of Legal Aid Queensland. You can contact these firms if you think you might be eligible for Legal Aid (see column 4 in the referral list).
- Some private solicitors on this list may provide free or discounted advice for an initial consultation (see column 4 in the referral list). You should confirm this with the solicitor **BEFORE** you arrange an appointment.
- Some solicitors also provide assistance on a speculative basis. This means that if you do not have sufficient property and/or income to pay for their services, they may agree to do the work on the basis that if you win the case they will take their costs out of your claim. However, if you lose the case they will not charge you some or all of the legal fees — but they **WILL** charge for outlays (e.g. expenses, court fees, barristers fees). You should ask the solicitor whether they do speculative work, and if they agree to help you on a speculative basis; they should advise you in writing of the agreements and what is meant by 'speculative'.
- Some solicitors and barristers may conduct certain work on a pro bono basis (i.e. for free). Any such arrangement is a private one between you and the solicitor or barrister. It is separate from Caxton Community Legal Centre.

WILL THE SOLICITORS ON THIS LIST TAKE ON MY CASE?

We cannot guarantee that the solicitors listed here will take on your case on an ongoing basis. We also cannot guarantee that the solicitors listed will be able to see you at all because their availability will depend on their other work commitments in relevant legal areas and individual willingness to act for you. It is vital to ensure that you seek legal assistance as soon as possible if your matter is likely to go to court.
